Please give us detailed information about your nominees, as we must make an accurate judgment as to our choices. List qualifications on the enclosed applications. Be sure to include both men and women candidates.



HALL OF FAME

ACTIVE COACHES AWARD

Criteria for selecting candidates:

1. Candidate must be an active head coach in the year of consideration.
2. Must be, or have been, a head varsity coach in a sport for a minimum of ten (10) calendar years in New Jersey. Considerable attention will be given for longevity.
3. Must display an excellent degree of coaching skills. Consideration given to the following:
 - a. overall record
 - b. state championships
 - c. sectional/district championships
 - d. county championships
 - e. conference championships
 - f. coaching honors - i.e., coach of the year (please designate level – i.e., league)
4. Should have a high standard of ethics and integrity. The candidates and their teams should have demonstrated high levels of sportsmanship. The committee suggests that the coach exemplify the highest standards of fair play and conduct, both on and off the field of play.
5. Contributions to the total athletic picture, such as presenter at coaching clinics, written publications, and be a recognized authority in the field. Contributions to the NJSCA, NJSIAA and community service also considered.
6. Nomination must be submitted by recognized coaches associations, athletic conferences, and athletic directors or under the sponsorship of the representative appointed by the New Jersey Scholastic Coaches Association or a member of NJSCA Hall of Fame.
7. **2011-2012 NJSCA membership required for Active Coaches. (Membership not required for Inactive Coaches.)**

RETIRED COACHES AWARD

Nominations will be forwarded in the same manner as for active awards.

Criteria for these awards:

1. Must be retired from active head coaching.
2. Candidate must have been a head varsity coach for a minimum of 10 calendar years in New Jersey or the candidate must have made significant contributions to the NJSCA and/or the NJSIAA.
3. Candidate must have met the same requirements of excellence, ethics, and contributions to the profession as an active coach.
4. NJSCA membership not required.
