1. Welcome and introductions

2. Review of previous Post-Season Minutes

• Previous year minutes were accepted by Sharon Hughes 2nd by Andrew Hopman

3. Correspondence-

- Received an email from one of the coaches asking for separate meetings for the Boys/Girls Volleyball Committees. Also, the coach was looking for representatives Big North and the NJIC. If the Committees separate then there would be more room to add coaches from all over the state. Beginning with fall 2025, there will be a separate Girls and Boys Volleyball Committee.
- Andrew Hopman gave statistics that say 97% of Boys and 98% of Girls teams played best
 of three all season. He also asked if so many teams aren't playing best of five, why make
 the playoffs best of five. It was explained that this has been a two-year process and has
 been approved by the membership, and it will be implemented for the 2025-26 school year

4. Review of the regular season (Positive / Negative)

- Scott Atkinson proposed that until a majority of the schools are playing best of five can we
 hold off playing best of five in the state tournament. Keep best of five as an option during
 the season but delay best of five in the post season.
- During the 2025-26 school year, if schools during the regular season want to play best of three, they will be allowed to continue to play best of three. For the State Tournament in Boys and Girls Volleyball it will be played BEST OF FIVE.

5. Review of the post-season (Positive / Negative)

- Scott Atkinson addressed a concern about Boys Group 1 South. He stated that there were 36 teams in that section and 24 in every other section. He stated that this should be looked into.
